ASSIGNMENT

WHEREAS, WE, SETH J. AND SHIVA SHARAREH covenants that she has full right to convey her entire interest herein assigned, and that she has not executed, and will not execute, any agreement in conflict herewith;

AND SHIVA SHARAREH further covenants and agrees that she will communicate to ASSIGNEE any facts known to her respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute and reissue applications, make all rightful oaths and generally do everything possible to aid ASSIGNEE to obtain and enforce proper patent protection for said improvements in all countries.

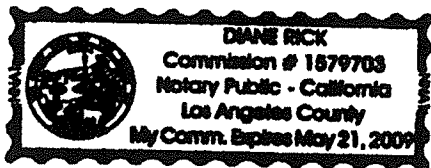


