ASSIGNMENT OF PATENT RIGHTS

WHEREAS, the following co-inventors, namely, Marek Pokorny residing at Jelinkova 1048, 29306 Kosmonosy, Czech Republic; and Vladimir Velebny residing at Sadova 1466, 56402 Zamberk, Czech Republic, have co-invented an "APPARATUS FOR PRODUCTION OF TWO-DIMENSIONAL OR THREE-DIMENSIONAL FIBROUS MATERIALS OF MICROFIBRES AND NANOFIBRES" as fully disclosed in a United States application for patent and filed on July 26, 2012, Serial No. 13/575,537, which claims priority to PCT/CZ2011/000013, filed on February 3, 2011, which claims priority to Czech Serial No. PV2010-93, filed on February 5, 2010 ("the Priority Applications").


