
AUTHORIZE AND REQUEST the issuing authority to issue and an all United States and foreign patents granted on such improvements to the Assignee;

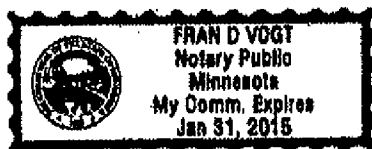


