
8. All international rights of priority associated with said invention, applications, patents and like protection;

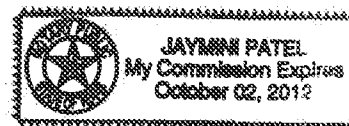
