FIGURE 3 is a bottom view of the SEMI-AUTOMATIC FIRE ARM;


FIGURE 4 is a top view the SEMI-AUTOMATIC FIRE ARM;


FIGURE 5 is a front view of the SEMI-AUTOMATIC FIRE ARM; and

The ornamental design for a SEMI-AUTOMATIC FIRE ARM, as shown, and described.











