NOW THEREFORE, for the sum of \$1.00 and other good and valuable consideration to Assignor in hand paid, the receipt and sufficiency of which are hereby acknowledged, Assignor has sold, assigned, and transferred and by these presents does hereby sell, assign and transfer to the said Assignee, and said Assignee's legal representatives, successors and assigns, any and all of the entire right, title and interest in and to the Design and the Patent and Design Rights;

UPON SAID CONSIDERATION, the Assignor hereby covenants and agrees with the said Assignee that it will not execute any writing or do any act whatsoever conflicting with these presents, and that it will, at any time upon request, without further or additional consideration, but at the expense of the said Assignee, execute such additional assignments and other writings and do such additional acts as said Assignee may deem necessary or desirable to perfect the Assignee's enjoyment of this grant, and render all necessary assistance in making applications for and obtaining original, continuation, continuation-in-part, continuing prosecution, divisional, renewal, reissue, reexamined, or extended patents or design registrations in any country or region in the world, and execute confirmatory assignments or acknowledgments of this assignment as necessary for full enjoyment of the Design and the Patent and Design Rights and for recording in foreign patent offices, and in enforcing any rights or choses in action accruing as a result of the Patent and Design Rights, by giving testimony in any proceedings or transactions involving such Design and/or the Patent and Design Rights, and by executing preliminary statements and other affidavits, it being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of, the assigns and legal representatives of both parties;

UPON SAID CONSIDERATION, Assignor represents and warrants that Assignor has the right, title, and authority to execute this Assignment and to convey any and all right, title, and interest in the Design and the Patent and Design Rights, and that Assignor has not conveyed

nor will convey hereafter all or part of the Design and the Patent and Design Rights to a third party; and


