
PATENT ASSIGNMENT

For good and valuable consideration, receipt of which is hereby acknowledged, We, Scott H. Wilson, Isabel Grace Wilson and Ava Anita Wilson of, 1916 W. Huron, Chicago, Illinois 60622, the United States of America, hereby sell and assign to Wimo Labs, LLC ("Assignee"), a corporation organized and existing under the laws of the State of Illinois, having its principal place of business at 1032 W. Fulton Market Street, Chicago, Illinois 60607, U.S.A., its successors, assigns, nominees, or other legal representatives, the entire right, title, and interest in and to the invention entitled "Crayon Stylus" invented by us, and the application for United States patent therefor, which has not yet been assigned a Serial No., the declaration for which is being concurrently executed, and any and all other applications therefor or arising therefrom, including all applications claiming the benefit thereof, and all original and reissued patents granted on any such application, and all divisions and continuations of any such application, including the subject matter of any and all claims which may be obtained in every such patent, and the right to apply for and obtain patents, registered designs and Utility Model Registrations which may be granted thereon in any foreign countries. I further covenant and agree that I will, at any time upon request, do everything legally possible to aid the Assignee, its successors, assignees, nominees, or other legal representatives, either in its or their own names, to apply for, obtain, and enforce proper patent, registered design and/or Utility Model protection for said invention in all countries, all without further consideration but at the expense of the Assignee, its successors, assigns, nominees, or other legal representatives.
