ASSIGNMENT

WHEREAS, we, Marwane Ansari, Allon G. Englman, Philip B. Gelber, Joel Jaffe, Ryan Summers, Jamie Vann, and John Walsh, have invented certain new and useful improvements in the following:

WAGERING GAME APPARATUS AND METHOD TO PROVIDE A TRUSTED GAMING ENVIRONMENT

for which we have made application for United States Letters Patent, the said application having been filed on November 1, 2007, as Application No. 61/001,335;

We also hereby sell and assign to said ASSIGNEE, its successors, assigns and legal representatives the full and exclusive rights, title and interest to the invention disclosed in said application throughout the world, including the right to file applications and obtain patents, utility models, industrial models and designs for said invention in its own name throughout the world, including all rights of priority, all rights to publish cautionary notices reserving ownership of said invention and all rights to register said invention in appropriate registries; and


We further agree to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title and interest in ASSIGNEE, its successors, assigns and legal representatives.

We hereby further agree that we will communicate to said ASSIGNEE, or its successors, assigns and legal representatives, any facts known to us respecting any improvements; and, at the expense of said ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all provisional, divisional, continuation, continuation-in-part, reissue and substitute applications, make all lawful oaths, and generally do everything possible to vest title in said ASSIGNEE and

to aid said ASSIGNEE, its successors, assigns and legal representatives to obtain and enforce proper protection for said invention in all countries.


We further authorize and direct the ASSIGNEE and its attorneys to insert above the application number of said application now identified as Docket No. 47079-559PL01 as soon as the same shall have been made known to them by the U.S. Patent and Trademark Office.






