PATENT ASSIGNMENT

WHEREAS, I THOMAS M. WICKER, have invented certain new and useful improvements in the following: "Document Containing Security Images," for which a U.S. Patent Application No. 10/555,936, was filed December 15, 2006, and issued March 15, 2011, as U.S. Patent No. 7,906,198;

WHEREAS, DOCUMENT SECURITY SYSTEMS, INC., a corporation organized and existing under the laws of the State of New York, having its principal place of business at 28 East Main Street, Suite 1525, Rochester, New York, 14614, (hereinafter referred to as "ASSIGNEE"), is desirous of acquiring my entire right, title and interest in and to the invention, and in and to the said application and any Letters Patent that have issued and that may issue from applications claiming the benefit of, and priority to, said application, and including the right to sue and collect damages by reason of any past infringement of said Letters Patent, including U.S. Patent No. 7,906,198;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I do hereby sell, assign, transfer, and deliver unto ASSIGNEE, its successors, assigns and legal representatives the entire right, title and interest in and to said invention and in and to said applications and all patents which may be granted or have been granted therefore, including U.S. Patent No. 7,906,198, and including, but not limited to, all past and future causes of action for patent infringement of said patents, including for any infringement occurring prior to execution of this Patent Assignment, and the rights to all provisionals, non-provisionals, divisions, reissues, substitutions, continuations, continuation-in-part and extensions thereof; and I hereby authorize and request the Commissioner of Patents and Trademarks to issue all patents for said invention, or patents resulting therefrom, insofar as our interest is concerned, to the said ASSIGNEE of our entire right, title and interest.

I also hereby sell and assign to said ASSIGNEE, its successors, assigns and legal representatives the full and exclusive rights, title and interest to the invention disclosed in said applications throughout the world, including, but not limited to, any such applications previously filed, and including the right to file applications and obtain patents, utility models, industrial models and designs for said invention in its own name throughout the world including all rights of priority, all rights to publish cautionary notices reserving ownership of said invention and all rights to register said invention in appropriate registries; and

I further agree to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title and interest in ASSIGNEE, its successors, assigns and legal representatives.

I hereby further agree that I will communicate to said ASSIGNEE, or its successors, assigns and legal representatives, any facts known to us respecting any improvements; and, at the expense of said ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, make all lawful oaths, and generally do everything possible to vest title in said ASSIGNEE and to aid said ASSIGNEE, its successors, assigns and legal representatives to obtain and enforce proper protection for said invention in all countries.

AND, I agree, without additional consideration, to take such further action and to promptly execute such additional documents as may be necessary to perfect the title of

ASSIGNEE's successors in interest in and to the 7,906,198 patent and any and all divisions, reissues, continuations and extensions thereof.

AND, I hereby request the Commissioner of Patents and Trademarks (the "Commissioner") to record this Patent Assignment to ASSIGNEE with respect to U.S. Patent No. 7,906,198.


