ASSIGNMENT

WHEREAS, ERAN SHARON and IDAN ALROD, hereinafter called the "Assignors", have made the invention described in the United States patent application entitled FLASH MEMORY WITH RANDOM PARTITION, for a full description of which reference is here made to an application for Letters Patent of the United States filed on July 2, 2012, and assigned Application Serial No. 13/539,969:

and benefit of the Assignee, its successors and assigns, to the full end of the term or terms for all such patents. The Assignors hereby sell, assign, and transfer the entire right, title and interest to the Assignee as of the day of filing the application identified above.

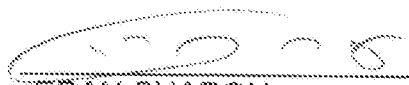

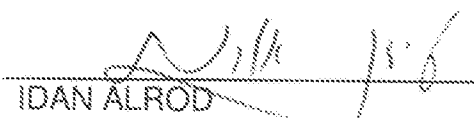
