ASSIGNMENT

(JOINT)

THIS ASSIGNMENT, by (1) Eugene Patrick Dougherty, Jr. and (2) Raymond Martin Carter, residing in (1) Newark, DE, US and (2) Philadelphia, PA, US, respectively (hereinafter referred to as "the Assignors"), witnesseth:


