ASSIGNMENT

WHEREAS, I, Douglas G. NOW THEREFORE in consideration of the payment to the Assignor by the Assignee of the sum of ONE DOLLAR (\$1.00) in the lawful money of Canada and other good and valuable consideration, the receipt of which is hereby acknowledged by the Assignor, the Assignor does hereby sell, assign, transfer and convey unto the Assignee its successors and assigns, all of his right, title and interest in and to the invention, any application for Industrial Design and Design Patent in any country to be filed, and any Industrial Design and Design Patent for the inventions that may be granted and in any re-issue or extension thereof and in any improvements in the inventions now existing or hereinafter arising in Canada, the United States of America and all other foreign countries, the same to be held and enjoyed by the Assignee as it would have been held and enjoyed by the Assignor had the sale, assignment, transfer and conveyance not been made.

THE Assignor hereby further agrees, undertakes and covenants that he/she will sign or execute such further documents, assurances, applications, instruments or any other writing that may be requested by the Assignee or their legal representatives for the purpose of obtaining or issuing any Industrial Design and Design Patent for the inventions or any re-issue or extensions thereof, or any improvement therein in order that all of his/her right, title and interest in the same may be vested in the Assignee, its successor and assigns.
