DEED OF ASSIGNMENT

This ASSIGNMENT is made the 10th day of November 2011

BETWEEN

KONINKLIJKE PHILIPS ELECTRONICS N.V., a public limited company organized and existing under the laws of The Netherlands, having its registered office at Groenewoudseweg 1, 5621 BA Eindhoven, The Netherlands ("Assignor") of the one part,

AND

TRIXELL, a société par actions simplifiée governed by French law, having its head office at ZI Centr' Alp, 38430 Moirans, France ("Assignee") of the other part.

This Deed of Assignment is to confirm the following:

Assignor is the registered owner of the US patent applications and granted patents listed in the Annex ("the Assigned Patents");

In consideration of the Assignment Fee set forth in the Intellectual Property Assignment Agreement, the receipt and sufficiency of which are hereby acknowledged, Assignor has, effective as of 10 November 2011, assigned to Assignee all right, title and interest in and to the Assigned Patents, subject to:

- (i) Assignor and its Affiliates retaining a world-wide, royalty-free, non-exclusive, unrestricted and irrevocable license under the Assigned Patents for the lifetime of the Assigned Patents, to use the Assigned Patents for and in any and all activities and applications that it or its Affiliates see fit, including, without limitation, the right to manufacture, use, import, offer to sell, sell or otherwise dispose of any product (including software), process or service including the right to have any such product made for it and/or its Affiliates or sold or otherwise disposed of for it or its Affiliates by third parties; and
- (ii) all prior commitments and prior undertakings vis-à-vis third parties entered into by Assignor or its Affiliates;

and Assignee has accepted said assignment.

When used in this Deed of Assignment, "Affiliate" shall mean any legal entity (i) owned or controlled by Assignor (ii) owning or controlling Assignor, or (iii) owned or controlled by the entity owning or controlling Assignor, at the 10th of November 2011 or at any time thereafter. For the purpose of this definition, an entity shall be deemed to own or control another entity if more than 50% (fifty per cent) of the stock of the latter entity, ordinarily entitled to vote in the election of directors (or, if there is no such stock, more than 50% (fifty per cent) of the ownership of or control in the latter entity) is directly or indirectly held by the owning or controlling entity.

The assignment of right and title in and to the Assigned Patents to Assignee does not include the right to claim for damages resulting from any act of infringement having occurred prior to the effective assignment date specified above. That right is retained by Assignor.

Assignor hereby grants full power of attorney to Assignee to submit this Deed of Assignment, including the Annex, to the patent authorities of the USA, and to request those authorities to record the assignment of the legal title to the Assigned Patents from Assignor to Assignee in the appropriate registers provided that, where possible, the retained license to Assignor and its Affiliates shall be simultaneously recorded in those registers.
