ASSIGNMENT

WHEREAS, DON E. CANSINO, BRADY C. TSURUTANI, EARL J. BONOVIK and CHARLES W. 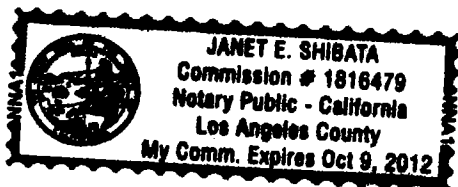

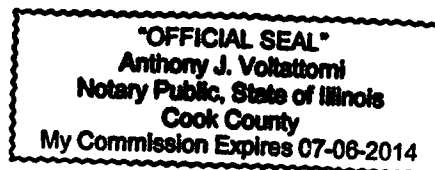
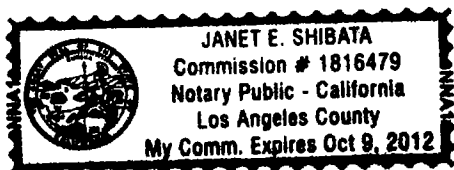
