Assignor hereby sells, assigns, transfers and sets over to Assignee, and its lawful successors and assigns, all of Assignor's undivided right, title and interest in and to the Patents, the inventions claimed therein, and all of Assignor's rights appurtenant thereto, including all of Assignor's right, title and interest to each of the following: the right to apply for any letters patent for said inventions in the United States of America and in any and all foreign countries; any and all other applications for letters patent on said inventions, in whatsoever countries, including all divisional, renewal, substitute and continuation applications based in whole or in part upon said inventions or upon said Patents; any and all letters patents that may issue thereon in the United States and foreign countries and any and all reissues, extensions, renewals, divisions, or continuations of letters patents granted for said inventions or upon said Patents, to the full end of the term or terms for which said letters patents may be issued; every priority or other right accorded by every international convention, treaty or agreement that is or may be predicated upon or arise from said inventions; and the right to bring actions for infringement of said Patents occurring prior to and after this Assignment, along with the right to all remedies, including damages, resulting from such infringement, wherein said Patents are all to be held and enjoyed by Assignee, and its successors and assigns, all the same as Assignor would have held and enjoyed had this Assignment not been made.

3. Assignor hereby requests and authorizes the Commissioner of Patents of the United States Patent and Trademark Office and the empowered officials of all other countries to grant, issue and transfer any letters patent for said inventions to Assignee, as assignee of the entire right, title and interest in, to and under said Patents, in accordance with this Assignment.

4. To the extent reasonably requested by Assignee, Assignor binds itself, and its successors and legal representatives, to execute and deliver to Assignee, and its successors and assigns, at Assignee's cost and expense, any further documents or instruments and to perform any and all further acts that are necessary, at Assignee's cost and expense, to enable or assist Assignee, and its successors and assigns to (a) file applications for letters patent for said inventions in any country in which Assignee may elect to file such applications; (b) vest in Assignee, and its successors and assigns, the title herein conveyed and intended to so be, and to enable such title to be recorded in the United States and each foreign country in which each such application may be filed so that any patent issued thereon shall be issued to vest in Assignee, and its successors and assigns; and (c) bring and prosecute actions for infringement of said Patents occurring prior to or after this Assignment.

5. In the event of any conflict between this document and the Asset Purchase Agreement, the Asset Purchase Agreement shall govern.
