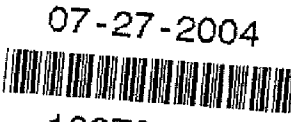

ACKNOWLEDGEMENT by an Employee of the Right to apply for a Patent and AN ASSIGNMENT made on the 13 February 2004 BETWEEN

STEPHEN RICHMOND of British nationality, resident at 38 Huntingdon Gardens, Christchurch, Dorset BH23 2TW, United Kingdom (hereinafter referred to as "Inventor"); and

CHRISTOPHER MANN of British nationality, resident at 49 Barton Drive, Barton-On-Sea, Hampshire BH25 7JH, United Kingdom (hereinafter referred to as "Inventor"); and

ANDREW BOARD of British nationality, resident at 42 Grove Road, Wimborne, Dorset BH21 1BW, United Kingdom (hereinafter referred to as "Inventor"); and

YONGGANG JIANG of Chinese nationality, resident at 76 Antler Drive, New Milton, Hampshire BH25 5GG, United Kingdom (hereinafter referred to as "Inventor"); and

GENETIX LIMITED, a legal body organized under the laws of England having a place of business at Queensway, New Milton, Hampshire BH25 5NN, United Kingdom (hereinafter referred to as "the Employer").

WHEREAS :-

- (A) Each Inventor claims jointly with the other Inventor(s) to have made the Invention described in US Patent Application Serial Number 10/631,845 filed 1 August 2003 (hereinafter referred to as "the Invention"); and

Each Inventor hereby undertakes to the Employer that he/she will at the expense of the Employer execute all documents and do all such acts and things as the Employer may in its absolute discretion consider necessary or desirable to enable Letters Patent or any form of protection to be issued in respect of the Invention in any part or parts of the world and to vest the same in the name of the Employer or its nominee free from all encumbrances and to enable or to assist the Employer or its nominee to defend oppositions to grant thereof, to maintain the same when granted and to present and prosecute for the infringement thereof.


