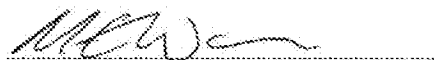
And I hereby authorize and request the Director of the USPTO to issue said United States Letters Patent to said Assignee, as assignee of the whole right, title and interest thereto;
