

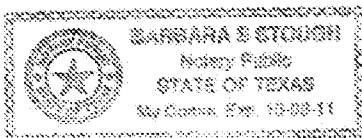

Cover Sheet information must be submitted with each document to be recorded.
