THIS DEED dated the 5<sup>TH</sup> day of JANUARY Two thousand  
and nine *ten*

BETWEEN:

Colin G. Caro of Imperial College of Science, Technology and  
Medicine, Exhibition Road, London, SW7 2AZ, United Kingdom  
(hereinafter called "Prof. Caro") of the first part;

Ioannis Petousis, a Greek citizen of 141A Lower Richmond Road,  
London, SW15 1EZ, United Kingdom (hereinafter called "Mr.  
Petousis") of the second part;

Brian G. Falzon of Monash University, Building 31, Clayton  
Campus, Wellington Road, Clayton, VIC 3800 Australia  
(hereinafter called "Dr. Falzon") of the third part;

Imperial College of Science, Technology and Medicine of  
Exhibition Road, London, SW7 2AZ, United Kingdom (hereinafter  
called "the College") of the fourth part;

Imperial Innovations Limited incorporated and registered in  
England and Wales with company number 2060639 whose registered  
address is at Level 12, Electrical and Electronic Engineering  
Building, Imperial College, London, SW7 2AZ (hereinafter called  
"Innovations") of the fifth part.

WHEREAS

1. Prof. Caro, Mr. Petousis and Dr. Falzon (hereinafter  
collectively called "the Inventors") have invented the  
invention (hereinafter called "the Invention") which is the  
subject of the patent applications listed in the schedule  
attached hereto (hereinafter called "the Patent Applications").

2. At the time of his contribution to the Invention Prof.  
Caro was a Professor of Physiological Mechanics at the College.

He also held a position in Veryan Medical Limited (the "Company") as Technical Director and to the extent that the Invention was created as a result of those duties, then the Company has a share in the rights in the Invention ("Company IP").

3. At the time of his contribution to the Invention Dr. Falzon was employed as Senior Lecturer at The Department of Aeronautics by the College and so by virtue of Section 39 of the Patents Act 1977 any such rights that he may have in the Invention, in his capacity as an employee of the College, belong to the College.

4. At the time that Mr. Petousis made his contribution to the Invention he was a researcher at the College on an International transfer.

5. The Inventors and the College (the "Assignors") agree that all of the rights in the Invention (save the Company IP) should be assigned to Innovations.

NOW THEREFORE:-

1. The Assignors HEREBY ASSIGN to Innovations with full title guarantee all right title and interest (save the Company IP) in and to the Invention, the Patent Applications and any subsequent applications for intellectual property rights in respect of the Invention in any country of the world including:

- (i) The right to file applications for, and be granted, patents, utility models or other intellectual property rights in any country of the world (and including supplementary protection certificates, divisions, continuations, continuations in part, national or regional phases, reissues and extensions) in respect of the Invention, whether

under national, regional or international arrangements;

- (ii) The right to claim priority under any national, regional or international law or treaty from any of the Patent Applications or any other applications for intellectual property rights in respect of the Invention;
- (iii) The right to recover and take all such proceedings as may be necessary for the recovery of damages or otherwise in respect of all infringements of any of the Patent Applications or any other intellectual property rights arising therefrom, whether committed on, before or after the date of this assignment, including the right to issue proceedings and be awarded damages or relief in respect of any right conferred by the publication of any of the Patent Applications.

TO HOLD the same unto Innovations absolutely

- 2. The Assignors hereby covenant with Innovations if and when required by Innovations to sign execute and do all such further documents, acts or things as may be necessary or desirable to enable Innovations to procure and enjoy the full benefit of the Invention and the Patent Applications or any patents or patent applications that may result therefrom including if required the execution of further assignments by way of confirmation of this assignment and the execution of documents in connection with the Invention in the Inventors' own names in respect of the United States of America or any other country.
- 3. The Assignors hereby represent, warrant and undertake that:
  - (i) the Assignors and the Company are the sole owners of

the Invention and the Patent Applications; and

(ii) none of them, nor any third party on their behalf, has licensed, assigned, covenanted not to sue or dealt in any way with the Invention or the Patent Applications.

- 4. This Deed and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the law of England and Wales. The parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this assignment or its subject matter or formation (including non-contractual disputes or claims).






