### RECITALS



2. The Assignor agrees to execute and deliver all documents reasonably required for such further patent applications (if any), and for recordal of this assignment, at the Assignee's expense.
3. The Assignee agrees to pay any statutory charges, taxes or duties payable in relation to this assignment.
4. The Assignor warrants that he has provided the Assignee with the results of any documentary searches carried out by or on behalf of the Assignor, or the Assignor's predecessor in title, prior to the grant of the Patents, whether conducted in Australia or elsewhere, for the purposes of assessing the patentability of the Inventions.


