ASSIGNMENT

WHEREAS, WE, **Eva Ackerman, Yanwei Cen, William Francis Flynn and Richard Garza** have invented certain new and useful methods, devices, and/or systems for which a United States Patent application entitled “**Flushing Method for Refrigeration or Air Conditioning System**” is filed herewith (“Application”); and

And we hereby authorize and request the Commissioner of Patents and other authorities in foreign countries to issue any and all patents on said invention or resulting from said Application and from any and all divisions, continuations, continuations-in-part, and reissues thereof, to **THE RECTORSEAL CORPORATION**, as assignee of our entire interest, and hereby covenant that we have the full right to convey the entire interest herein assigned, and that we have not executed and will not execute any agreement in conflict herewith.

And we further hereby covenant and agree that we will, at any time, upon request, execute and deliver any and all papers that may be necessary or desirable to perfect the title of said invention and to such patents as may be granted therefor, to **THE RECTORSEAL CORPORATION**, its successors, assigns, or other legal representatives and that if **THE RECTORSEAL CORPORATION**, its successors, assigns or other legal representatives shall desire to file any divisional, continuation, or continuation-in-part applications or to secure a reissue of such patents, or to file a disclaimer relating thereto, will upon request, sign all papers,

make all rightful oaths and do all lawful acts requisite for the filing of such divisional or continuation applications, or such application for reissue and the procuring thereof, and for the filing of such disclaimer, without further compensation but at the expense of said assignee, its successors, or other legal representatives.

And we do further covenant and agree that we will, at any time upon request, communicate to **THE RECTORSEAL CORPORATION**, its successors, assigns or other legal representatives, such facts relating to said invention and patents or the file history thereof as may be known to me, and testify as to the same in any interference or other litigation when requested so to do, without further compensation but at the expense of said assignee, its successors, or other legal representatives.
