and are about to make application for United States Letters Patent therefor, the same having been executed by us on even date(s) herewith; and

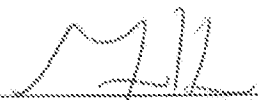

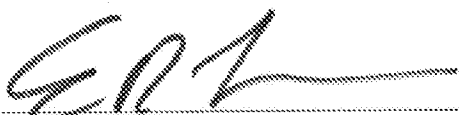
