ASSIGNMENT

WHEREAS, Tekelec International SPRL (a private limited liability company incorporated in Belgium) ("Assignee"), a subsidiary of Tekelec Global, Inc. (a corporation duly organized and existing under the laws of the state of California, having its principal office and place of business at 5200 Paramount Parkway, Morrisville, North Carolina 27560 (hereinafter, "Assignor")) and NewNet Communication Technologies, LLC (a limited liability company incorporated under the laws of the state of Delaware (hereinafter, "NewNet")) have entered into that certain Share Purchase Agreement dated July 7, 2012 (the "Purchase Agreement"), whereby NewNet has agreed to purchase, effective as of the Completion Date (as defined in the Purchase Agreement), all of the issued shares in Tekelec Netherlands Group, B.V. (a Netherlands corporation, having offices at Gebouw Azië 6th Floor, Hoogoorddreef 5, 1101 BA Amsterdam, The Netherlands (hereinafter, "Tekelec Netherlands"));

WHEREAS, Assignor owns certain Patent Rights (defined below) applicable to the business conducted by Assignee, which Patent Rights Assignor desires to assign to Assignee prior to the Completion Date, for further assignment to Tekelec Netherlands immediately prior to the Completion Date in contemplation of the consummation of the Purchase Agreement; and

WHEREAS, Assignor is receiving, through its subsidiaries or otherwise, good and valuable consideration from NewNet on account of the sale of all of the issued shares in Tekelec Netherlands.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor does hereby sell, assign, transfer and convey unto Assignee, or its designees, all of Assignor's right, title and interest in and to the patent applications and patents listed below, any patents, registrations, or certificates of invention issuing on any patent applications listed below, the inventions disclosed in any of the foregoing, any and all counterpart United States, international and foreign

Assignor also hereby authorizes the respective patent office or governmental agency in each jurisdiction to issue any and all patents or certificates of invention which may be granted upon any of the Patent Rights in the name of Assignee, as the assignee to the entire interest therein.

Assignor will, at the reasonable request of Assignee, do all things necessary, proper, or advisable, including without limitation the execution, acknowledgment and recordation of specific assignments, oaths, declarations and other documents on a country-by-country basis, to assist Assignee in obtaining, perfecting, sustaining, and/or enforcing the Patent Rights. Such assistance shall include providing, and obtaining

from the respective inventors, prompt production of pertinent facts and documents, giving of testimony, execution of petitions, oaths, powers of attorney, specifications, declarations or other papers and other assistance reasonably necessary for filing patent applications, complying with any duty of disclosure, and conducting prosecution, reexamination, reissue, interference or other priority proceedings, opposition proceedings, cancellation proceedings, public use proceedings, infringement or other court actions and the like with respect to the Patent Rights. The Assignee agrees to pay, or to reimburse Assignor for, all reasonable expenses and costs actually incurred by Assignor in providing such assistance described in this paragraph, but Assignor shall not demand any further consideration therefor.

The terms and conditions of this Assignment shall inure to the benefit of Assignee, its successors, assigns and other legal representatives, and shall be binding upon Assignor, its successor, assigns and other legal representatives.
