**FIRST:** That the Board of Directors of said corporation, by the unanimous written consent of its members, duly adopted resolutions setting forth a proposed amendment of the Amended and Restated Certificate of Incorporation of said corporation, declaring said amendment to be advisable. The resolution setting forth the proposed amendment is as follows:

**RESOLVED**, that the Certificate of Incorporation of Fairchild Imaging, Inc. be amended by changing the Article thereof numbered "FIRST" so that, as amended, said Article shall be and read as follows:

"FIRST: The name of the corporation (the "Corporation") is:

**BE IT FURTHER RESOLVED**, that this amendment to the Certificate of Incorporation shall be filed with the State of Delaware to be effective upon such filing.


