the said **SCHONBEK WORLDWIDE LIGHTING INC.**, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith.


AND I HEREBY further covenant and agree that I will communicate to the said **SCHONBEK WORLDWIDE LIGHTING INC.**, its successors, legal representatives and assigns, any facts known to me respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all non-provisional applications and all divisional, continuing and reissue applications thereof, make all rightful oaths and generally do everything possible to aid the said **SCHONBEK WORLDWIDE LIGHTING INC.**, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.
