ASSIGNMENT

WHEREAS, we, JAMES R. LEININGER, a citizen of the United States of America with mailing address at 18615 Tuscany Stone, Suite 200, San Antonio, Texas 78258; RUSSELL M. HERRING, a citizen of the United States of America residing at 128 W. Mistletoe, San Antonio, Texas 78212; MICHAEL R. GIROUARD, a citizen of the United States of America residing at 15618 Partridge Trail, San Antonio, Texas 78232; JOSE E. CAVAZOS, a citizen of the United States of America residing at 11 Inwood Terrace, San Antonio, Texas 78248; EDWARD R. JONES, a citizen of the United States of America residing at 4285 Hollow Stone Drive, College Station, Texas 77845; and WILLIAM E. BROAD, a citizen of the United States of America with mailing address at 7700 West Glasgow Pl. #7D, Littleton, Colorado 80128 (collectively hereafter referred to as the "ASSIGNORS"), have invented certain new and useful improvements in the inventions ("Inventions") disclosed in U.S. Patent Application Serial No. 13/542,596 entitled METHOD AND APPARATUS FOR DETECTING SEIZURES, filed on July 5, 2012, and naming James R. Leininger, Russell M. Herring, Michael R. Girouard, Jose E. Cavazos, Edward R. Jones, and William E. Broad as inventors, and in PCT Patent Application Serial No. PCT/US12/45609 also entitled METHOD AND APPARATUS FOR DETECTING SEIZURES, filed on July 5, 2012, and naming James R. Leininger, Russell M. Herring, Michael R. Girouard, Jose E. Cavazos, Edward R. Jones, and William E. Broad as inventors (collectively, the "Applications"); and

WHEREAS, LGCH, Inc. NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, we, the said ASSIGNORS, have sold, assigned, transferred, and set over, and by these presents do hereby sell, assign, transfer, and set over, unto the said ASSIGNEE, its successors, legal representatives and assigns, the entire right, title and interest in, to and under the Rights of Action, the Inventions, and the Applications, and all non-provisional applications claiming priority thereto, and all divisionals, renewals, continuations, and continuations-in-part thereof, and all Letters Patent of the United States which may be granted thereon and all reissues, reexaminations, and extensions thereof, and rights of priority based thereon, and all applications for Letters Patent and equivalents thereof which have been or may hereafter be filed for said Inventions in any country or countries foreign to the United States, and all Letters Patent which may be granted for said Inventions in any country or countries foreign to the United States and all extensions, renewals and reissues thereof; and ASSIGNORS hereby authorize and request the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said Inventions to said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

Each ASSIGNOR, for such ASSIGNOR but not for any other ASSIGNOR, HEREBY covenants that such ASSIGNOR has full right to convey the interest herein assigned, and that such ASSIGNOR has not executed, and will not execute, any agreement in conflict herewith, and that each ASSIGNOR will not challenge or dispute the ownership, validity or enforceability of the Applications or any other Letters Patent that may issue for the Inventions, or the Rights of Action, either directly or indirectly, nor allow any person or entity under Assignor's control to do so.

ASSIGNORS HEREBY further covenant and agree that ASSIGNORS will, and will cause persons under their control to, communicate to said ASSIGNEE, its successors, legal representatives and assigns, any facts known to ASSIGNORS respecting the Inventions and said Applications, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths, and generally do everything possible to aid said ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce and protect the Rights of Action, the Applications and the Inventions in all countries, provided only that ASSIGNEE shall pay, or reimburse ASSIGNORS for, all reasonable out of pocket expenses incurred by ASSIGNORS incident to the performance of their obligations under this paragraph.
