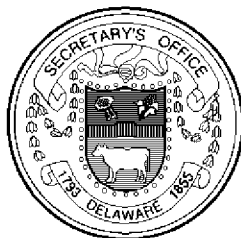

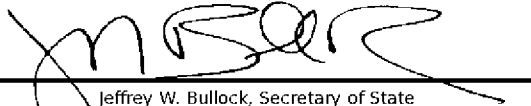

**CERTIFICATE OF MERGER
OF
ANALYTICA OF BRANFORD, INC.
WITH AND INTO
PERKINELMER HEALTH SCIENCES, INC.**

Pursuant to Title 8, § 252(e) of the Delaware General Corporation Law and Title 33, §819 of the Connecticut General Statutes, the undersigned corporations executed the following Certificate of Merger:

FIRST: The constituent business corporations participating in the merger are:

(i) Analytica of Branford, Inc., which is incorporated under the laws of the State of Connecticut ("Analytica"); and

(ii) PerkinElmer Health Sciences, Inc., which is incorporated under the laws of the State of Delaware.

SECOND: Analytica has an authorized capitalization consisting of 5,000 shares of common stock, with no par value.

THIRD: The name of the surviving corporation is PerkinElmer Health Sciences, Inc. (the "Surviving Corporation").

FOURTH: An Agreement and Plan of Merger has been approved, adopted, certified, executed and acknowledged by (i) Analytica and its shareholders in accordance with its Certificate of Incorporation and Title 33, Sections 600-998 inclusive of the Connecticut General Statutes, and (ii) the Surviving Corporation and its shareholders in accordance with Title 8, §252 of the Delaware General Corporation Law and its Certificate of Incorporation, as required by Title 8, § 252(e) of the Delaware General Corporation Law and Title 33, §817 of the Connecticut General Statutes.

FIFTH: The Certificate of Incorporation of the Surviving Corporation shall be its Certificate of Incorporation.

SIXTH: The merger is to become effective at 11:59 p.m., Eastern Daylight Time, on June 30, 2009.

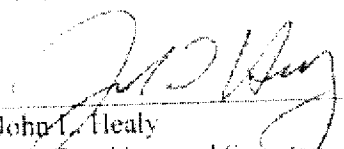

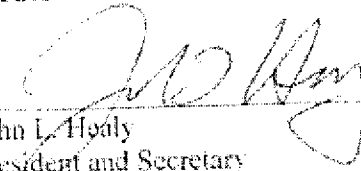
