And I do hereby covenant for myself and for my respective legal representatives and agree with Assignee that I have granted no right or license to make, use or sell said inventions in the United States of America to anyone except the Assignee, that prior to the execution of this deed my right, title and interest in and to said inventions as the inventor has not been otherwise encumbered, and that I have not executed and will not execute any instrument in conflict herewith.
