This Assignment is made as a deed on

2012 between:

- (1) **BTG International Limited** whose company registration number in England and Wales is 2664412 and whose registered address is at 10 Fleet Place, Limeburner Lane, London, EC4M 7RD, England ("BTG"), and
- (2) **The University of Greenwich**, a company limited by guarantee, incorporated in England & Wales of Old Royal Navy College, Park Row, Greenwich London SE10 9LS ("Greenwich").

Whereas:-

- A. BTG is the proprietor and/or beneficial owner of the patents and patent applications, details of which are set out in the Schedule to this Agreement, (all such patents and patent applications are herein together called the "Patents").
- B. Pursuant to a Revenue Sharing Agreement (the "Revenue Sharing Agreement") made between Greenwich and BTG dated 30 July 2002, BTG has agreed that the Patents shall be re-assigned to Greenwich on the terms hereinafter set forth.

Now it is hereby agreed as follows:-

1. BTG hereby assigns to Greenwich all its right, title, and interest in the Patents, free from encumbrances, except for encumbrances disclosed or otherwise known to Greenwich, and together with all rights transferable with such encumbrances.
2. Further Assurance
 - 2.1 BTG shall, at the request and cost of Greenwich, execute and do all such documents, acts and things as may be necessary on the part of BTG to give effect to the terms of this Agreement.
 - 2.2 BTG hereby confirms that, as at the date of this Agreement, it is not aware of any unauthorised use of any of the Patents.
3. BTG has agreed to pay the renewal fee amounting to £171.50 in relation to Patent No. GB 2415378, subject to reimbursement of the same by Greenwich, which Greenwich undertakes to pay against invoice therefor, on the execution and exchange of this Agreement.
4. This Agreement shall be read and construed in accordance with, and governed by, English law, and the parties submit to the jurisdiction of the English Courts.
