INTELLECTUAL PROPERTY RIGHTS ASSIGNMENT
AND LICENSE

THIS INTELLECTUAL PROPERTY RIGHTS ASSIGNMENT AND LICENSE is made on June 15 2012 (this "Deed"),

BETWEEN:

- (1) MARTEK BIOSCIENCES CORPORATION, a private company with limited liability, incorporated under the laws of Delaware, having its seat (*statutaire zetel*) in Columbia, MD, USA, and its registered office at 6480 Dobbin Road Columbia, MD 21045, USA (the "Assignor"); and
- (2) DSM IP ASSETS B.V., a private company with limited liability (*besloten vennootschap met beperkte aansprakelijkheid*) incorporated under the Laws of The Netherlands, having its seat (*statutaire zetel*) in Heerlen, The Netherlands and its registered office at Het Overloon 1, 6411 TE Heerlen, The Netherlands, and registered with the Dutch Commercial Register (*Handelsregister*) under number 14076998 (the "Assignee").

Together, the "Parties".

WHEREAS:

- (I) The Assignor and the Assignee are parties to the IP Transfer and License Agreement entered into on June 15 2012 (the "IP Transfer and License Agreement");
- (II) Pursuant to Clause 2.1 of the IP Transfer and License Agreement, the Assignor has agreed to assign the IP Rights (for the avoidance of doubt, not including the economic interest in the IP Rights which shall remain with the Assignor) vested in the Assignor to the Assignee; and
- (III) Pursuant to Clause 2.4 of the IP Transfer and License Agreement, the Parties wish to enter into the assignment of the IP Rights on the basis of and subject to the terms and conditions contained in the IP Transfer and License Agreement and as further specified in this Deed.

THE PARTIES AGREE as follows:

1. DEFINITION

In this Deed:

"IP Rights" means the Assignor's patents and patent applications set out in SCHEDULE 1 to this Deed, (i) whether registered, deposited, filed or not, (ii) including any and all rights in connection with patents, applications or the right to apply for any and all of such rights, (iii) including any and all other assets, rights, receivables, claims and property of whatever kind or nature in connection with these rights, (iv) in any and all applications that claim the benefit of or priority to the patents and patent applications set out in SCHEDULE 1 to this Deed, including non-provisional applications, continuing (continuation, divisional, or continuation-in-part) applications, reissues, extensions, renewals and reexaminations of the patent applications or Letters Patents therefor, to the full extent of the term or terms for which Letters Patents issue, and (v) in any and all inventions described in the patents and patent applications set out in SCHEDULE 1 to this Deed, and in any and all forms of

intellectual and industrial property protection derivable from such patents and patent applications, and that are derivable from any and all continuing applications, reissues, extensions, renewals and reexaminations of such patents and patent applications, including, without limitation, patents, applications, utility models, inventor's certificates, and designs together with the right to file applications therefor; and including the right to claim the same benefit or priority rights from any previously filed applications under the International Agreement for the Protection of Industrial Property, or any other international agreement, or the domestic laws of the country in which any such application is filed, as may be applicable.

2. ASSIGNMENT

Pursuant to the IP Transfer and License Agreement, the Assignor hereby assigns to Assignee all its ownership and rights, including benefit and priority rights, to the IP Rights (but not full *economic ownership* of the IP Rights which will remain vested in Assignor), and ensures that Assignee will obtain, as per the effective date hereof, the legal title to the IP Rights (i.e., the *legal ownership* of the IP Rights) as Assignee, and Assignee hereby accepts from Assignor the transfer of the same.

3. LICENSES

- 3.1 If and to the extent that this assignment of any and all rights, legal title and interest in and to the IP Rights, will for whatever reason not have full force and effect anywhere in the world, the Assignor hereby grants to the Assignee, to the extent permitted by applicable law, a royalty free, fully paid-up, world-wide, transferable, irrevocable license under the IP Rights, including but not limited to any and all rights as referred to in Clause 2 (*Assignment*) above, which license the Assignee hereby accepts.
- 3.2 The Assignor shall remain the unrestricted owner of all economic interest in the IP Rights and shall remain free to exploit the IP Rights in an unrestricted fashion. For that purpose, the Assignee hereby grants to the Assignor, to the extent permitted by applicable law, a royalty free, fully paid-up, world-wide, transferable, irrevocable license under the full and entire IP Rights, to use the IP Rights in an unrestricted fashion, which license the Assignor hereby accepts. The license includes, but is not limited to, the Assignor's right to develop, manufacture, market, offer, sell, lease and distribute products and to grant respective licenses to third parties.

4. POWER OF ATTORNEY

To facilitate the assignment of the IP Rights, the Assignor, to the fullest extent permitted by applicable law, hereby appoints the Assignee to be its true and lawful attorney (with full power of substitution and delegation) for and on its behalf and in its name or in the name of the Assignee and as the Assignor's attorney, to act and sign, execute, seal, deliver, acknowledge, file, register and perfect any and all assurances, documents, instruments, agreements, registrations, certificates and consents and to do any and all such acts and things as the Assignor itself could do in relation to the IP Rights or in relation to any other matters dealt with in this Deed. The Assignor will ratify and confirm whatever the Assignee shall do or cause to be done in pursuance of the powers conferred to it

hereunder. It is confirmed that the said appointment in terms hereof is made by the Assignor for the benefit of the Assignee.

5. **GOVERNING LAW**

- 5.1 This Deed is governed by and shall be construed in accordance with The Netherlands law.

6. **MISCELLANEOUS**

- 6.1 This Deed and the IP Transfer and License Agreement contain the entire agreement of the Parties in relation to its subject matter and shall supersede all previous agreements and arrangements made by the Parties in relation to its subject matter.
- 6.2 The Schedule shall form a part of this Deed.
- 6.3 This Deed may only be amended or supplemented in writing, signed by all Parties.

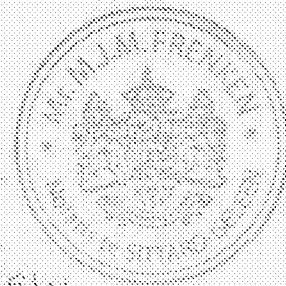

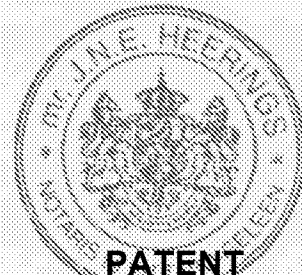

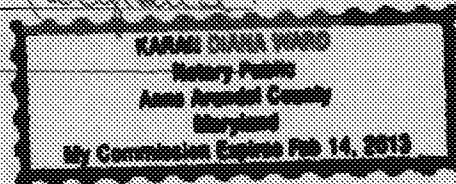
