ASSIGNMENT AND AGREEMENT

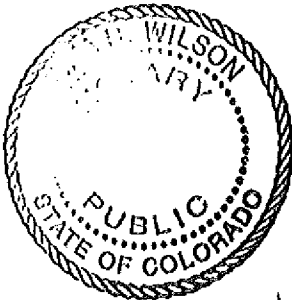


