which applications and invention are collectively referred to herein as "the Invention."



I confirm that at the time the Invention was made, I was under an obligation to assign the Invention to The Trustees of Princeton University.

I hereby grant the law firm of Klarquist Sparkman, LLP, the power to insert on this Assignment any further information that may be necessary or desirable in order to comply with all applicable legal requirements, including the rules of the United States Patent and Trademark Office, for submitting and recording this document.

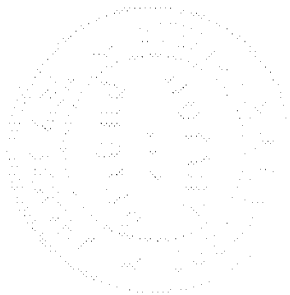
