ASSIGNMENT

WHEREAS We, Kazuhiro KIDO of Tokyo, Japan and Chiho MAKIFUCHI of Tokyo, Japan and Junko KIYOHARA of Tokyo, Japan (hereinafter referred to as "ASSIGNORS") have invented certain new and useful improvements in:

X-RAY IMAGING SYSTEM

which claims priorities to Japanese Application Nos. 2010-061973, filed on March 18, 2010, 2010-061983, filed on March 18, 2010, and 2010-061993, filed on March 18, 2010, for which I am about to file or have filed an application for Letters Patent of the United States;

AND WHEREAS, Konica Minolta Medical & Graphic, Inc. (hereinafter referred to as "ASSIGNEE"), a corporation organized and existing under the laws of the Country of Japan, having a place of business at 1, Sakura-machi, Hino-shi, Tokyo 191-8511 Japan, is desirous of acquiring an interest in the United States and all foreign countries, in and to the said invention and Letters Patent to be obtained therefor;
