# ASSIGNMENT

SHUT-OFF VALVE FAULT DIAGNOSIS DEVICE AND FUEL SUPPLY SYSTEM

which claims priority to Japanese Application No. 2010-064466 filed March 19, 2010 and for which I am about to file or have filed an application for Letters Patent of the United States;
