RELEASE OF SECURITY INTEREST IN PATENT COLLATERAL

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the adequacy, receipt and sufficiency of which are hereby acknowledged, Releasor hereby relinquishes, releases and discharges its lien(s) on and security interest(s) in, and any and all other rights in or to the Collateral, and any other patent and patent application that Releasor has, had or could have had pursuant to the Patent Collateral Agreement, and hereby terminates the Patent Collateral Agreement. Releasor hereby further authorizes Releasee to take any and all actions, including filing and recording this document with any and all appropriate governmental authorities, to effect and further document the release made hereby.
