ASSIGNMENT AGREEMENT

On the date shown below and for good and valuable consideration the receipt of which I acknowledge, I have made the following assignment and promises to PASS of Sweden AB, ("Assignee"), a Swedish Aktiebolag having an address of Kyrkogatan 17 B, SE-735 32 Surahammar, Sweden, in connection with my invention of a new, original, FURNITURE DEVICE ADAPTED TO RECEIVE THE WEIGHT OF A BEING ("the Invention").

 - (d) all extensions, renewals, reissues, divisions, and continuations of the Application or any patents issuing therefrom.

2. I agree that, upon the request of Assignee, I will:
 - (a) execute any and all divisional, continuation and renewal applications for the Invention or improvements;
 - (b) execute any supplemental oath relating to the Invention or improvements;
 - (c) execute any application for reissue or extension of any Letters Patent that may be granted upon the application;
 - (d) cooperate to the best of my ability in connection with any interference or post issuance proceeding relating to the Application or any patent issuing therefrom;
 - (e) perform any and all affirmative acts to obtain Letters Patent covering the Invention and vest all right in such Letters Patent in Assignee; and
 - (f) perform such additional acts as Assignee may deem necessary or expedient in connection with any of the matters stated above.

3. I covenant and warrant that as of the effective date of this Assignment Agreement, I am the true and lawful owner of the entire right, title, and interest in the Invention, application for Letters Patent, and any Letters Patent which may issue from the Application, and have the full

right and power to convey the same; that the same are free and clear of all liens, charges and encumbrances whatsoever; and that I have not executed and will not execute any agreement in conflict with this Assignment Agreement.

4. This Assignment Agreement is binding upon, shall inure to the benefit of, and shall be performed by the parties named, their heirs, administrators, legal representatives, successors and assigns.
