Delaware St., San Mateo, California 94403 USA and Peter Lombrozo, residing at 716 Coast Range Dr., Scotts Valley, California 95066 USA (hereinafter, individually and collectively, the "Assignor"), have invented certain new and useful systems, devices, and methods disclosed and described in a utility application for Letters Patent in the United States ("U.S."), entitled "Vertebral Joint Implants and Delivery Tools," which can be identified in the United States Patent and Trademark Office ("USPTO") by Application No. 12/653,283, filed on 10 December 2009, with attorney docket no.
