ASSIGNMENT

NOW, THEREFORE, in fulfillment of my obligation, and for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by me, I confirm that I have assigned, sold, transferred and set over, and, to the extent I have not, by these presents do assign, sell, transfer and set over, unto said ASSIGNEE, and its successors and assigns, the entire right, title and interest in and to (a) the Inventions and all rights throughout the world arising therefrom; (b) the Application, including all divisions, continuations and substitutions thereof; and (c) all applications, patents (including utility patents, patents of addition, utility models, designs, and corresponding registration rights, without limitation) that issue on the Application, or that claim any of the Inventions, including all reissues, renewals and extensions thereof, for the United States, its territories and possessions and all foreign countries, including the right to file corresponding applications for patent on said Invention in any and all foreign countries; and (d) the right to claim priority under any and all treaties and conventions, including the Paris Convention for the Protection of Industrial Property, arising from the Application and all corresponding applications, and any division, continuation or substitution thereof, the same to be held and enjoyed by ASSIGNEE, its assigns and successors, as fully and entirely as the same would have been held and enjoyed by me, had this Assignment not been made.



I represent and covenant that no assignment, mortgage, sale, license, pledge, encumbrance or alienation of the Inventions, the Application, or any other right assigned hereunder, has been or will be made or entered into which would conflict with the assignment thereof to ASSIGNEE.

I hereby authorize and request the Director of the United States Patent and Trademark Office to issue all patents based on the Application and each division, continuation, substitution, reissue, renewal and extension thereof to said ASSIGNEE, its successors and assigns.
