- that Bauer Hockey Corp. should and does own all rights, title and interest in and to the Inventions outside the U.S., and all rights, title and interest in and to all of the Application's corresponding or counterpart patent applications outside the U.S. (including, but not limited to, Canadian Application No. 2,718,456, filed October 22, 2010, and European Application No. 10252086.3, filed December 9, 2010, both entitled "Blade Constructs and Methods of Forming Blade Constructs") and any patents that have issued or may issue from such corresponding or counterpart patent applications outside the U.S., including, but not limited to, design patents and registrations, petty patents and utility model patents, and all continuations, continuations-in-part, divisions, reissues, extensions, and renewals of any of them, and the right to claim the priority benefit of the Application for any such corresponding or counterpart patent applications outside the U.S. (collectively and severally "Ex-U.S. Patent Rights");
