I/We hereby authorize and request the Patent Office officials in the United States and any and all foreign countries to issue any and all of said Letters Patent, when granted, to Assignees, as the assignees of my/our entire right, title and interest in and to the same, for the sole use of the Assignees, their successors and assigns.

Further, I/we agree that I/we will communicate to Assignees, or their representatives, any facts known to me/us respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitution, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to Assignees, make all rightful oaths and generally do everything possible to aid Assignees, their successors and assigns, to obtain and enforce proper protection for said invention in the United States and in any and all foreign countries.
