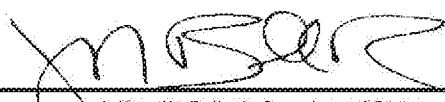

The undersigned, Alain Rossmann, hereby certifies that:

ONE: He is the duly elected and acting Chief Executive Officer of Pervasive Security Systems, Inc., a Delaware corporation (the "**corporation**").

TWO: The corporation was originally incorporated on October 19, 2000 under the name SecretSEAL Inc.

THREE: The Amended and Restated Certificate of Incorporation of the corporation was filed with the Secretary of State of Delaware on December 15, 2000.

FOUR: The Second Amended and Restated Certificate of Incorporation of the corporation was filed with the Secretary of State of Delaware on February 20, 2001.

FIVE: The Third Amended and Restated Certificate of Incorporation of the corporation was filed with the Secretary of State of Delaware on September 21, 2001.

SIX: The Fourth Amended and Restated Certificate of Incorporation of the corporation was filed with the Secretary of State of Delaware on July 18, 2002.

SEVEN: This Certificate of Amendment of the Fourth Amended and Restated Certificate of Incorporation has been duly adopted in accordance with the provisions of Sections 228 and 242 of the General Corporation Law of the State of Delaware.

Article 1 of the Fourth Amended and Restated Certificate of Incorporation of the corporation is hereby amended and restated to read in its entirety as follows:

"ARTICLE 1.

The name of the corporation is PSS Systems, Inc."
