### **ASSIGNMENT BY INVENTORS**

**THIS ASSIGNMENT**, made by Morten SOFUSSEN residing at Thunøgade 1, 1th, 8000 Aarhus C, DENMARK; and Uffe STÆHR residing at Birkhøjen 15A, 8382 Hinnerup, DENMARK, (each hereinafter referred to as ASSIGNOR);

**WHEREAS**, having created certain new, original and ornamental designs entitled **PUMP CONTROL HOUSING**, set forth in a design patent application for Design Letters Patent of the United States, filed on August 6, 2012 as U.S. Patent Application No. 29/421,511; and

**WHEREAS**, Grundfos Holding a/s, a Corporation organized under and pursuant to the laws of Denmark having its principal place of business at Poul Due Jensens Vej 7-11, 8850 Bjerringbro, DENMARK (hereinafter referred to as Assignee), is desirous of acquiring the entire right, title and interest in and to the designs throughout the United States, and all right, title and interest in, to and under any and all Design Letters Patent of the United States;

**FOR GOOD and VALUABLE CONSIDERATION**, the full receipt and sufficiency of which are hereby acknowledged, ASSIGNOR, intending to be legally bound, does hereby:

**SELL, ASSIGN, TRANSFER and CONVEY** to ASSIGNEE the whole and entire right, title and interest for the United States and its possessions and territories in and to the designs which are disclosed in the above-identified patent application, including those incorporated by reference, and, in and to any and all United States patent applications related thereto including, but not limited to, the original and all divisionals, continuations, continuations-in-part, substitutes, reexaminations, reissues and all other applications for patent which have been or shall be filed in the United States on the designs; all original, reissued and reexamined patents and registrations and extensions thereof which have been or shall be granted or issued in the United States on the designs to the full end of the term or terms for which the patent(s) may be granted or issued, as fully and entirely as the same would have been held by the undersigned ASSIGNOR had this Assignment not been made; and specifically including all rights of priority created by the above patent application under any treaty, convention or law relating thereto;

AUTHORIZE and REQUEST the issuing authority to issue any and all United States patents granted on the designs to ASSIGNEE;

WARRANT and REPRESENT that no assignment, grant, mortgage, license or other agreement affecting the rights and property of the designs herein conveyed has been or will be made to others by ASSIGNOR, and that the full right to convey the same as herein expressed is possessed by ASSIGNOR;

AGREE and UNDERTAKE, when requested and at the expense of ASSIGNEE, to carry out in good faith the intent and purpose of this Assignment, ASSIGNOR will execute all original, continuations, continuations-in-part, substitutes, reexaminations, reissues, and all other United States patent applications on the designs; execute all lawful oaths, declarations, assignments, powers of attorney and other papers; communicate to ASSIGNEE all facts known to ASSIGNOR relating to the designs and the history thereof; and generally do everything possible which ASSIGNEE shall consider desirable for vesting title to the designs in ASSIGNEE, and for securing, maintaining and enforcing proper patent and design registration protection for the designs; all without further compensation to ASSIGNOR;

TO BE BINDING on the heirs, assigns, representatives and successors of ASSIGNOR and extending to the successors, assigns, and nominees of ASSIGNEE.

ASSIGNOR further acknowledges an obligation of assignment of these inventive designs to ASSIGNEE at the time each of the inventive designs was made.
