## RELEASE OF SECURITY INTEREST IN PATENTS

**THIS RELEASE OF SECURITY INTEREST IN PATENTS** (this “Release”) is made as of October 9, 2012 (“Effective Date”) by and between Collective Licensing International, LLC, Collective Brands, Inc. (formerly known as Payless ShoeSource, Inc.), Payless Shoesource Worldwide, Inc., San Jose Acquisition Corp., Saucony, Inc., SR Holdings Inc., SRL, Inc., The Keds Corporation, and Sperry Top-Sider, Inc. (each a “Grantor” and collectively, the “Grantors”), and Citicorp North America, Inc. (in such capacity, the “Administrative Agent”).

**WHEREAS**, pursuant to the terms and conditions of that certain Patent Security Agreement by and between Grantors and Administrative Agent dated as of August 17, 2007 (the “Patent Security Agreement”), Grantors granted to Administrative Agent a continuing security interest in and to, and lien on, all of Grantors’ right, title and interest in, to and under all of the patents and patent applications owned by Grantors (collectively, the “Patents”), including, without limitation, the United States patents set forth on Schedule A attached hereto;

**WHEREAS**, Grantors and Administrative Agent entered into the Patent Security Agreement pursuant to the terms and conditions of that certain Pledge and Security Agreement by and between Grantors and Administrative Agent dated as of August 17, 2007 (the “Security Agreement”);

**WHEREAS**, the Patent Security Agreement was recorded with the U.S. Patent and Trademark Office (“USPTO”) on April 25, 2008 at reel/frame number 020845/0889;

**WHEREAS**, Grantors have paid all of their outstanding indebtedness to Administrative Agent; and

**WHEREAS**, Administrative Agent desires to terminate all such security interests on behalf of itself and the secured parties (as agent), and to execute and deliver to Grantors all deeds, assignments and other instruments as may be reasonably necessary to release the security interests relating to the Patents.

**NOW, THEREFORE**, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent on behalf of itself and as agent to the secured parties hereby terminates the Patent Security Agreement and the Security Agreement and relinquishes unto Grantors the continuing security interest in and lien on the Patents and otherwise assigns, grants and conveys to Grantors any and all right, title, and interest the Administrative Agent or secured parties may have in, to or under the Patents in order to revest in Grantors full and unencumbered title to said Patents.

Administrative Agent represents and warrants that: (i) it has the full power and authority to execute this Release; and (ii) it has not recorded or otherwise evidenced its security interest with respect to any patent or patent application owned by Grantors, other than the foregoing patents and patent applications set forth on Schedule A (attached hereto), in any jurisdiction throughout the world other than such filings made in the USPTO.

Administrative Agent shall, at Grantors’ expense, take all further actions, and provide to Grantors, Grantors’ successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or

other instruments), reasonably requested by Grantors to more fully and effectively effectuate the purposes of this Release.
