PATENT SECURITY AGREEMENT

Patent Security Agreement (this "Agreement") dated as of October 5, 2012 by and between RO-SEARCH, INCORPORATED, a North Carolina corporation (the "Grantor"), having its chief executive office at 5968 Commerce Boulevard, Morristown, Tennessee 37814-1051, and WELLS FARGO BANK, N.A., successor by merger to Wachovia Bank, National Association (the "Bank"), with offices at One Wells Fargo Center, TW15, 301 South College Street, NC 5562, Charlotte, NC 28288, for the benefit of the Bank to secure the Obligations (as defined in the Loan and Security Agreement) of Tactical Holdings Operations, Inc. ("Tactical"), Wellco Enterprises, Inc. ("Wellco"), Grantor, Mo-Ka Shoe Corporation ("Mo-Ka Shoe"), Altama Delta Corporation ("Altama"), Altama Delta (Puerto Rico) Corporation ("Altama PR"), Massif Holdings LLC ("Massif Holdings") and Massif Mountain Gear Company, L.L.C. ("Massif", collectively with Tactical, Wellco, Grantor, Mo-Ka Shoe, Altama, Altama PR and Massif Holdings, the "Borrowers") under that certain Loan and Security Agreement, dated as of April 2, 2010, by and among the Bank and the Borrowers (as amended, restated, supplemented or otherwise modified from time to time, the "Loan and Security Agreement") and the other Loan Documents. Capitalized terms used herein and not otherwise defined shall have the meanings given to such terms in the Loan and Security Agreement.

This Agreement is executed pursuant to the terms of that certain Fifth Modification and Waiver to Loan and Security Agreement, dated as of the date hereof, by and among the Bank and the Borrowers.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Grantor hereby grants to the Bank, a continuing security interest in all of the Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter arising or acquired:


- (i) each Patent and Patent application of the Grantor, including, without limitation, each Patent and Patent application described on Schedule A;
- (ii) all claims by the Grantor against third parties for past, present or future infringement of any Patent or Patent application, including, without limitation, any Patent or Patent application described on Schedule A; and
- (iii) all products and proceeds of the foregoing.

The rights and remedies of the Bank with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Loan and Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Agreement are deemed to conflict with the Loan and Security Agreement, the provisions of the Loan and Security Agreement shall govern.


