ASSIGNMENT

I hereby authorize and request the Patent Office officials in the United States and any and all foreign countries to issue any and all of said Letters Patent, when granted, to Kabushiki Kaisha Challenge Five, as the assignee of my entire right, title, and interest

in and to the same, for the sole use of Kabushiki Kaisha Challenge Five, and its successors and assigns.

Further, I hereby covenant and agree to and with Kabushiki Kaisha Challenge Five, and its successors and assigns, at the time of execution and delivery of these presents, that I am the sole and lawful owner of the entire right, title, and interest in and to the invention and the above-identified patent application(s), and that the same are unencumbered, and that I have good and full right and lawful authority to sell and convey the same in the manner herein set forth.

Further, I agree that I will communicate to Kabushiki Kaisha Challenge Five, or its representatives, any facts known to me respecting the invention, and testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, reissue, substitution, and extension applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to Kabushiki Kaisha Challenge Five, make all rightful oaths, and generally do everything possible to aid Kabushiki Kaisha Challenge Five, and its successors and assigns, to obtain and enforce proper protection for the invention in the United States and in any and all foreign countries.
