ASSIGNMENT



UPON SAID CONSIDERATIONS, Roman and Williams hereby agree with Waterworks that Roman and Williams will not execute any writing or do any act whatsoever conflicting with these presents, and that Roman and Williams will, at any time upon request, without further or additional consideration but at the expense of Waterworks, execute such additional assignments and other writings and do such additional acts as Waterworks may deem necessary or desirable to perfect Waterworks' enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, divisional, continuations, continuations-in-part, reexamined, reissued, or extended Letters Patent of the United States or of any and all foreign countries on said invention, and in enforcing any rights or choses in action accruing as a result of such applications or patents, by giving testimony in any proceedings or transactions involving such applications or patents, and by executing preliminary statements and other affidavits, it being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of the assigns and legal representatives of Roman and Williams and Waterworks;

AND Roman and Williams request the Commissioner for Patents and Trademarks to issue any Letters Patent of the United States which may be issued for said invention to Waterworks, its legal representatives, successors or assigns, as the sole owner of the entire right, title and interest in and to said patent and the invention covered thereby.
