**ASSIGNMENT**

WHEREAS, we, **BRIAN K. CASTER**, a citizen of the United States, residing at 6865 Lakeview Drive, Salinas, California 93907, **JENNIFER K. IZZO**, a citizen of the United States, residing at 162 Logan Street, Watsonville, California 95076, and **ARLEN DRAPER**, a citizen of the United States, residing at 604 East Park Drive, Payson, Arizona 85541 (hereinafter collectively referred to as "ASSIGNOR"), are the inventors of an invention entitled **BLUEBERRY PLANT NAMED 'DRISBLUESEVEN'**, for which an application for Letters Patent is being filed with the United States Patent and Trademark Office; and
