PATENT SECURITY AGREEMENT

This PATENT SECURITY AGREEMENT (the "Agreement"), dated as of October 15, 2012, is by and between BENETECH, INC., an Illinois corporation ("Grantor") in favor of GOLUB CAPITAL LLC, a Delaware limited liability company, as Administrative Agent (in such capacity, the "Grantee"), for the benefit of itself, all financial institutions that from time to time become lenders (the "Lenders") under the Credit Agreement (as hereinafter defined) and the other Secured Parties. The capitalized terms not otherwise defined in this Agreement shall have the meanings set forth in the Credit Agreement.

RECITALS

WHEREAS, Grantor, as Borrower, has entered into that certain Amended and Restated Credit Agreement dated as of even date herewith (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), with Grantee, the other loan parties party thereto from time to time, the Lenders and Golub Capital LLC, a Delaware limited liability company, as Revolver Agent, which provides for extensions of credit and other financial accommodations to be made to Borrower by Lenders; and

WHEREAS, pursuant to the terms of that certain Master Reaffirmation Agreement as of even date herewith (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Master Reaffirmation"), by and among Grantor, Grantee and the other Persons party thereto, Grantor has reaffirmed its grant of a security interest in substantially all the assets of Grantor (including all right, title and interest of Grantor in, to and under all now owned and hereafter acquired Patents and applications for Patents, and all products and proceeds thereof) to Grantee, as successor administrative agent to Golub Capital Incorporated (the "Resigning Administrative Agent"), for the benefit of Grantee, as Administrative Agent, Lenders and the other Secured Parties, to secure the payment of the Obligations, as such security interest was initially conveyed to Resigning Administrative Agent pursuant to that certain Security Agreement dated as of December 28, 2007 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), by and among Grantor, the Resigning Administrative Agent, and the other Persons party thereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor hereby grants to Grantee, a continuing security interest in all of Grantor's right, title and interest in, to and under the following (all of the following items or types of property being herein collectively referred to as the "Patent Collateral"), whether now owned or existing and hereafter created, acquired or arising:

- (i) each Patent and application for Patent listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof; and
- (ii) all products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future infringement of any Patent.

Grantor hereby acknowledges and affirms that the rights and remedies of Grantee with respect to the security interest in the Patent Collateral made and granted hereby are more fully set forth in the Master Reaffirmation and the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. This Agreement and the transactions evidenced hereby shall be construed under the internal laws of the State of New York without regard to principles of conflicts of law.
