PATENT & INVENTION ASSIGNMENT

WHEREAS Holland Bloorview Kids Rehabilitation Hospital ("HBKRH"), the full post office address of whose principal office or place of business is 150 Kilgour Road, Toronto, Ontario M4G 1R8, is the owner of an invention entitled **TOPIC WORD GENERATION METHOD AND SYSTEM** (the "Invention") for which certain patent applications have been filed, as set out in Schedule "A" (the "Patents").

AND WHEREAS, Quillsoft Ltd. ("Quillsoft"), the full post address of whose principal office or place of business is Suite 308, 250 The Esplanade, Toronto, Ontario M5A 1J2, has acquired from HBKRH all of the rights, title, and interest in the Patent and Invention;

NOW THEREFORE, in consideration of the sum of one dollar (\$1.00), and other good and valuable consideration, the receipt of all of which is hereby acknowledged, HBKRH, by these presents confirms that HBKRH has sold, assigned and transferred and does hereby sell, assign and transfer unto Quillsoft, its full and exclusive rights to the Patents and Invention, and its entire rights, title and interest in and to any divisions, continuations, continuations-in-part, extensions of, and supplementary disclosures thereto, and, in jurisdictions where available, the right to claim damages for past infringement upon the Patents, together with its rights to claim the benefit of the right of priority provided by the International Convention for the Protection of Industrial Property based on the Patents.

HBKRH agrees that it will without further consideration do all such things and execute all such documents as may be necessary or desirable to obtain and maintain the Patents and for additions and modifications thereto in the United States of America and Canada, and to vest title thereto in Quillsoft the assignee, its successors, assigns and legal representatives or nominees.

HBKRH hereby authorizes and requests the Commissioner of Patents to issue any Letters Patent relating to the Patents to Quillsoft, the assignee of HBKRH's entire rights, title and interest in and to the Patents, for its sole use and benefit, and for the use and benefit of its successors and assigns, to the full end of the term for which Letters Patent may be granted as fully and entirely as the same would have been held by HBKRH had this assignment and sale not been made.

To evidence the fact that it has executed this agreement, a party to this agreement may send a copy of its executed counterpart to the other party to this agreement by facsimile transmission or other electronic transmission. That party shall be deemed to have executed this agreement on the date it sent such facsimile transmission or other electronic transmission. In such event, such party shall forthwith deliver to the other party the counterpart of this agreement executed by such party.
