ASSIGNMENT

And I hereby authorize and request the Commissioner of Patents and Trademarks and other authorities in foreign countries to issue any and all patents on said Inventions or resulting from said Application and from any and all divisions, continuations, continuations-in-part and other patent applications relating thereto and reissues thereof to **PORT-A-COOL, LLC**, as assignee of my entire interest, and hereby covenant that I have the full right to convey the entire interest herein assigned, and that I have not executed and will not execute any agreement in conflict herewith.

And I further hereby covenant and agree that I will, at any time, upon request, execute and deliver any and all papers that may be necessary or desirable to perfect the title of said Inventions, Application and patents as may be granted therefor, to **PORT-A-COOL, LLC**, its successors, assigns, or other legal representatives and that if **PORT-A-COOL, LLC**, its successors, assigns or other legal representatives shall desire to file any divisional, continuation, continuation-in-part applications or other patent applications thereon or to secure a reissue of such patent(s), or to file a disclaimer relating thereto, I will upon request, sign all papers, make all rightful oaths and do all lawful acts requisite for the filing of such applications, and the

procuring thereof, and for the filing of such disclaimer, without further compensation but at the expense of said assignee, its successors or other legal representatives.

And I do further covenant and agree that I will, at any time upon request, communicate to **PORT-A-COOL, LLC**, its successors, assigns or other legal representatives, such facts relating to said Inventions, Application and patents or the file history thereof as may be known to me, and testify as to the same in any interference or other litigation when requested so to do, without further compensation but at the expense of said assignee, its successors, or other legal representatives.
